## Attention Volunteers, School Activity Participants, and Coaches – New Laws in the Enforcement of Criminal Background Checks

One thing many retirees are happy to continue doing is "lend a hand" in extra-curricular activities (marching band, musicals, etc.), sports, recreation or volunteer programs. By now you may have heard the state and local governments have instituted changes in the requirements in and frequency of obtaining Act 151, Act 34, and Act 114 criminal history checks and child abuse releases. Based on the following definition, full- and part-time employees of schools with "direct contact with children" will need to undergo new criminal checks and fingerprinting: "Possibility of care, supervision, guidance or control of children by a paid employee or contractor of, or an employee of a person under contract with, a school entity." ### Did You Know? Updated R<sup>3</sup> Stats...

The <u>Retiree Resource Registry</u> (R<sup>3</sup>) for PMEA is a "win-win" because it documents (and celebrates) the unique gifts and past contributions of our retired members while providing service to those who need assistance. A "shout-out" and welcome go to our most recent enrollees James Falvo and Bret Mascaro (soon to be added and placed online). Here are the statistics regarding the current April 20<sup>th</sup> Registry:

- Number of Retired Members in the Registry = 101
- Expertise/interest in vocal music = 40%
- Expertise/interest in instrumental music = 75%
- Expertise/interest in classroom music = 46%
- Expertise/interest at elementary level = 69%
- Expertise/interest at middle school level = 76%
- Expertise/interest at high school level = 78%
- Expertise/interest at higher education level = 31%
- Help categories (see R<sup>3</sup> Help Index): accompanist, adjudications, arts advocacy, assessments, auditions, band, booster groups, chamber music, chaperoning, choral, choreography/dance, coaching, community ensembles, composing/arranging, core arts standards, curriculum writing, Dalcroze/eurhythmics, early childhood/pre-school, festival preparation, fund-raising, general music, guest conducting, guest lecturing, higher education, hosting a festival, instrument repair, instrument sales, jazz, Kodaly, leadership training, marching band, music appreciation, music theory, musicals, Orff, panel discussions, PCMEA/teacher training/mentoring, professional development, research, strings, technology, traveling/tours, voice, webinars, world drumming, and writing for PMEA News.
