## PMEA state leadership structure – Can you name these acronyms?



With a renewed focus on specialization and clarity of purpose, today's PMEA probably looks a lot different to "veteran" retired members than when we were active and attending conferences/meetings many years ago. Under the overall leadership of the PMEA Executive Committee and the State Board ("the buck stops here"), the governance is further

broken down into these committees of representatives:

- **AMEC:** Advancement of Music Education Council
- **PDOC:** Professional Development Operations Council
- **PSOC:** Past State Officers Council
- **SEC:** Student Events Council
- **TTRRC:** Teacher Training, Recruitment, and Retention Council

As Retired Member Coordinator, I attended the June 20<sup>th</sup> Student Events Council meeting at State College to present "A Close-up Look at the Retiree Resource Registry." I kept hearing that the Securities Exchange Commission was somehow involved in PMEA... ha-ha, a different SEC! This one is all about the festivals and fests across the state, and is ably led by Lisa Hummell from the Union School District.

Retired members are represented by the TTRRC (should they add another "r" for "retired?"). At Seven Springs, I will attend my first TTRRC meeting. In addition, I will present to the State Board the report "The State of the PMEA Retired Members," which will include statistics, goals, achievements, and a few "stories" of our retirees:

- Total PMEA Retired Members (as of March 2016) = **412** or **10%** of all membership
- Total members in the Retiree Resource Registry = **116** or **28%** of retired members
- Total members attending Spring Breakfast meeting = **28** or **7%** of retired members
- Total serving in state/district leadership positions = **> 11** or **> 3%** of retired members
- Total volunteers at 2016 Conference Info Booth = **9** or **2%** of retired members

## Retiree Resource Registry... going strong!

It is actually quite impressive that **28% of all PMEA retired members** have enrolled in the **PMEA Retiree Resource Registry (R<sup>3</sup>)**, and are willing to help out other members or serve as an "ask the expert." The free, informal consultant service is provided to first year teachers, new transfers/appointments, educators who have been assigned to a less familiar subject (e.g. a band director who is now directing choirs for the first time), PMEA council representatives and officers, or anyone who needs a little advice or insight in order to solve a problem. Among the R<sup>3</sup> jobs in 2015-16 were listening/audition committee members, guest conductors, accompanists, adjudication judges, registration aides, writers for *PMEA News*, etc. Interested in applying?
