i. PMEA staff/officers

PMEA State President (Phil Stattel), Immediate Past President (Tina Bennett), and Executive Director (Abi Young): President Stattel welcomed TTRR members and thanked them in advance for their work on the council; Tina discussed ideas for the Music Student Virtual Workshop (see 4b below); Abi Young reported the slow start of 2020-2021 membership renewals, PMEA affording an extra month of "forgiveness" to continue receiving communications, plans to send out (USPS) expired dues notices, creation and distribution of testimonies on "why it is important to renew your PMEA membership," and the sharing of these statistics: NAfME saw a 40% drop in expected membership renewals (September), which are similar to these PMEA's current enrollments:

- b. Collegiate Concerns

Annual costs of professional clearances continue to be a challenge for many college students (needed even for virtual field experiences); discussion shared that this requirement is being defined by individual school districts (professionals working in the same district need only to obtain security clearances once in five years) because legislators gave local school entities a wide degree of latitude for interpretation of the law; will become a possible legislative "ask" for future advocacy efforts (Mark Despokatis)

Requesting information on the "state of the state" (Jonathan Helmick): Do we know the number of PA music programs that have maintained their structure? How can we leverage resources to help programs which are experiencing a "gap year" for their students? What is the retention data for music educators in the state? Deitz reported that most PDE data is as much as 15 months behind.


