More emergency substitute certifications are being issued. It has been difficult to find qualified music educators to fill vacancies.  - 2021 virtual spring conference Future music educators participated in mentoring and professional development activities; participant reflections indicate the success of the program!
 - b. Mentoring Program Lisa Endler, Eric Plum Thank you to Lisa Endler, co-chair.
 - There are 76 trained mentors across the state with 3-4 active pairings. Mentors undergo two training sessions. This initiative recognizes the need to retain new teachers. Possible future ideas may include automatically linking PCMEA members to a PMEA mentor. It will be necessary to hear from PCMEA what they need/want in terms of the Mentoring Program, perhaps add these ideas into the Strategic Plan? Hoping to connect with PCMEA chapters, visit chapter meetings for a panel discussion or topic exploration regarding this topic. Visit Facebook page for further information.
 - c. PCMEA Amanda Herold
 - PCMEA members are hoping for more interaction amongst active PCMEA schools and those who do not have chapters. Amanda, et al, helping to renew Carnegie Mellon chapter.
 - Exploring the possibility of music educator honors symposium or PMEA session to provide opportunity to host a panel for prospective music educators (this has happened in the past and was paused for COVID) provides a relatable point of contact between PCMEA and PMEA members.

 - Political issues impacting music education: The governor cannot run for another term, PDE is anticipating change in political party. PDE political appointees are leaving which is particularly affecting certification issues and causing many problems, especially with music/art/dance certifications.
 - Trying to get schools up and running has been difficult with Department of Health and temperament of local school boards. School district noncompliance is causing a great deal of work outside realm of normal work. A challenging time for superintendents and principals.
 - Send any questions to David Deitz.
 - Missouri recently passed legislation permitting high school graduates with 20 hour training course to be substitute teachers.
- f. Others? SMTE, Region Representatives, etc.
 - Higher Education concerns there have been difficulties in placing students for practicum placements. K-12 teachers are reluctant to take them on. Pre-service teachers are required to complete 20 hours of observation. Some programs have been using videos to meet this requirement. K-12 teachers, please share videos that show you but not students. We can explore using existing YouTube content, as well.
 - SMTE conference report some groups are working on efforts to recruit new teachers to the field.
 - Recruiting into music ed programs brings about cyclical concerns if there are no teachers, jobs will be cut.
 - Consider the teacher work force in recruitment of students into teacher preparation programs.
 - Trades are recruiting students younger and younger music has to be at the table to considered as a career path. Consider Middle School as a setting where efforts can and should be focused.

PDE Educator Ethics Law Update to the PMEA Board October 17, 2021

- As posted in the *Pennsylvania Bulletin*, Volume 51, Issue 34 on August 31, 2021, revisions to the **PA "Code" of Professional Practice and Conduct** have been approved by the Pennsylvania Board of Education, Pennsylvania Department of Education (PDE), and the Pennsylvania Professional Standards and Practices Commission
- 2. The old "Code" had eleven sections; the new "Code" is organized into six sections:
 - Mission
 - Introduction
 - Definitions
 - Commitment to Students
 - Commitment to Colleagues
 - Commitment to the Profession
- 3. This "Code" is a regulation that licenses and governs all PA professional educators:
 - "Professional conduct defines interactions between the individual educator and students, the employing agencies, and other professionals..."
 - "This chapter makes explicit the values of the education profession. When individuals become educators in this Commonwealth, they make a moral commitment to uphold these values."
- 4. We are awaiting the final release of the official copy of this "Code" and updates on the Commission's website.
- 5. The final draft of revisions to the PA Chapter 49 Certification of Professional Personnel (with specific mandated competencies for ethics training to be covered in pre-service classes, induction programs, and professional development in-service workshops) was approved by the PA State Board of Education on September 9, 2021, and is currently being examined by the Independent Regulatory Review Commission.
- 6. PMEA is ahead of the curve in providing ethics training of its members: webinars, conference sessions, and PCMEA workshops.
